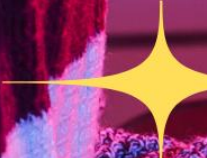

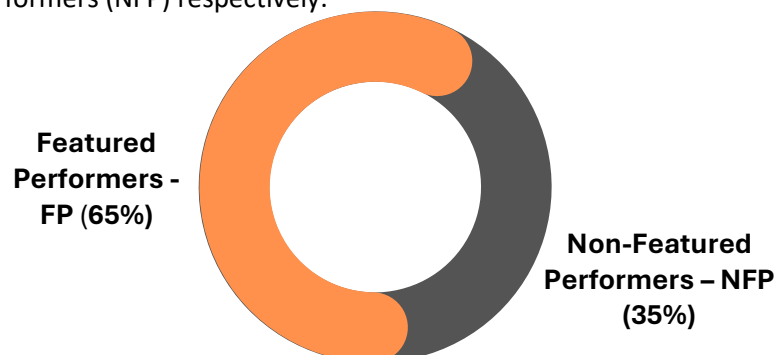
DISTRIBUTION POLICY PRINCIPLES

1. The RPM Board of Directors is responsible for determining the methods by which RPM revenue is allocated and distributed as outlined in the Memorandum and Article of Association. All aspects of distribution rules and processes to be transparent and easily understood.
2. All royalties collected by the Company in respect of rights granted by Members shall be applied first to payments of all expenses of and incidental to the management and operation of the Company, and then shall be allocated and distributed amongst the Members in accordance with a scheme of distribution to be determined and fixed from time to time by the Board.

DISTRIBUTION RULES

1. Division of Performer Track Allocation Between Performers

- a) The Performer Track Allocation is divided 65/35 between Featured Performers (FP) and Non-Featured Performers (NFP) respectively.



- b) Initial Allocation
 - All Featured Performers on the sound recording are allocated equal amounts of the Featured Performer Share, and the value of each such share will be set out.
 - All Non-Featured Performers on the sound recording are allocated equal amounts of the Non-Featured Performer Share, and the value of each such share will be set out

c) **Secondary Allocation**

- Where the allocations to Non-Featured Performers do not use all of the Non-Featured Performer Share, the balance is allocated between all the performers on the sound recording (including the Featured Performers), in proportion to their initial share of the Performer Track Allocation.
- Share allocation is based on “LINE UP COMPLETE” (total line up of performers in a track).

2. Pool Division

Royalties collected in a fiscal year shall be allocated into 3 main pools i.e. Public Performance, Airline, and Broadcast.

3. Frequency of Distribution

Royalties shall be distributed once a year.

4. Timing of Distribution

Distribute royalties after the end of financial year, which covers royalties collected from 1st January to 31st December of the preceding year. RPM shall endeavour to distribute the royalties within eighteen (18) months from the end of the corresponding financial year. For example, distribution to members for royalties 2017 should be targeted to be made in the year 2018, and not later than June 2019. The distribution to foreign collecting societies shall be made in accordance with the reciprocal arrangements made between RPM and the affiliated societies.

5. Minimum Payment

To avoid the unnecessary costs, RPM will not make the payment if, at any distribution, the total amount due is less than RM100.00 for RPM members. However, the payment will be made in the next distribution when the accumulative amount exceeds the above-mentioned amount.



6. Calculation of Net Distributable Royalties

The total amount of royalties to be distributed is arrived at as follows: -

7. Unlogged Performance Allocation (UPA)

- a) The UPA is made to compensate for performances that are omitted in our analysis due to sampling and other factors.
- b) UPA amount is fixed by the Board of Directors for each participating RPM member. A participating RPM member is one who was admitted to RPM membership in or before the Distribution Year in question and who earns performing royalty in the Distribution Year.
- c) UPA will be allocated to RPM member who earns royalties (exclusive of UPA) and cease to be allocated to a RPM member who has not earned any royalties for more than a years. However, UPA will reapply in the year the member begins to receive royalties again.
- d) No UPA is allocated for overseas societies.
- e) If no successor applies within three (3) years, the deceased's royalties will be ploughed back into the general pool in the 4th year's distribution and allocated proportionally to all parties receiving royalties in the current Distribution Year.

8. Payments to Foreign Collecting Societies

- a) Royalties collected by RPM on the basis of an agreement with affiliated societies will be distributed in proportion to music usage based on the information received in question, in accordance with the distribution rules which may be implemented or put in place by the Board.
- b) Foreign Collecting Societies will be responsible for covering the expenses related to taxes and administrative costs (these may include the costs of legal clarifications, translation costs, and costs that arose specifically in the exchange process with the respective country).



9. Royalties received from Foreign Collecting Societies

These royalties are 100% distributed to members on an annual basis. RPM do not deduct any administrative cost for such royalty payments.

10. Usage Report

RPM obtains the usage report or cue sheets from broadcasters and licensees.

DISTRIBUTION POLICIES & PROCEDURES

1. Distribution Policy 1

Recording performer with written mandate to RPM and have already submitted the updated Song List Submission form on or before 31 December each year.

2. Distribution Policy 2 - Public Performance Income- Sound Recording

100% of royalty collected based on full usage returns from all licensed radio stations.

3. Distribution Policy 3 - Public Performance Income- Karaoke & Music Video Recordings

100% of royalty collected based on 'Usage' returns from major licensed karaoke outlets.

4. Distribution Policy 4 - Broadcast Income- Radio & Television

- a) Based on individual licensed Radio & TV station income.
- b) Usage reports from licensed Radio & TV broadcasters.
 - For radio stations, 100% actual usage by individual station income.
 - If there is no usage report, the income will be parked under common public performance pool.
 - For TV stations (terrestrial & satellite), 50% based on actual TV reports and 50% of proportionate allocations by actual radio income value.
- c) Manual Cue sheets processing based on sampling.
- d) Computerized report- 100%



5. Distribution Policy 5 - Miscellaneous Income

- a) Public performance full annual usage returns from airlines.
- b) 100% based on usage returns where applicable.

6. Distribution Policy 6 - UPA - Cash Sharing

Each RPM member will be paid Unlogged Performance Allocation (UPA) based on Board of Director's discretion for the year of distribution.

CLAIM SONG LIST

- 1. Featured Performers (only for solo singers and duets)
 - a) Songs under this category will be automatically claimed based on the information available in the usage report.
 - b) ONLY eligible roles or instruments are ACCEPTED. Please refer to the list of eligible roles or instruments. (APPENDIX 1)
- 2. Bands/Groups/Collaborations and Non-Featured Performers (including musicians, backing vocals etc.)
 - a) Recording performers under this category are REQUIRED to submit the claimed song list on their own.
 - b) ONLY eligible roles or instruments are ACCEPTED. Please refer to the list of eligible roles or instruments. (APPENDIX 1)
 - c) All claims under this category MUST be accompanied with supporting documents for each song claimed.
- 3. Ratio for calculation: -

4. Total number of songs submitted:
 - a) Verified – proceed for payment.
 - b) Suspense – Conflict / Pending for Documents
 5. Claim will be kept in Suspense Account for 1 year, after which will be placed under Reserved Fund for distribution later to other eligible members.
